ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT

I am aware that during any trip or tour that I am voluntarily participating in under the arrangements of M&M Photo Tours, Inc., a Utah corporation, and its employees, agents and associates, certain risks and dangers exist while traveling in the United States, foreign countries, and wilderness areas in any country or territory that include without limitation the possibility of property damage, bodily injury and death. There is a possibility of accident or illness occurring without access to immediate or timely medical treatment or facilities. There is a risk of tropical or communicable diseases, food-related illnesses, the potential for personal injury and property damage, wildlife, quarantine, political instability, terrorism, strikes, government restrictions or regulations change, thefts, pilferage and accidents during travel while on foot or by aircraft, train, automobile, van, bus, boat, ship or any other form of transportation.

I understand that such risks cannot be totally eliminated without jeopardizing the essential qualities of this trip/tour and that M&M Photo Tours, Inc., its employees, agents and associates assume no obligation to reduce or limit the risks inherent in travel. In consideration of, and as part payment for the privilege to participate in such trip/tour and/or other activities and services arranged for me by M&M Photo Tours, Inc. its employees, agents and associates, I have and do hereby assume all risks, and hereby indemnify M&M Photo Tours, Inc. its employees, shareholders, agents and associates, and hold them harmless from any and all liability, actions, causes of actions, debts, claims, and demands of every kind and nature, howsoever caused, which I now have or which may arise in connection with any of my trips or tours and participation in any activities arranged for me by M&M Photo Tours, Inc. its employees, agents and associates. I further represent that I am in sufficient medical and mental health to participate in the rigors of such trip/tour. The terms hereof shall serve as my assumption of all risks and a waiver of all claims resulting from my assumption of these risks for myself, my heirs, executors and administrators, and for all members of my family.

I assume sole responsibility for my actions on this trip or tour, including without limitation the responsibility to conduct myself in strict compliance with all laws, regulations and ordinances of any kind in the countries, states, municipalities or localities visited on the trip or tour. I agree to indemnify and hold M&M Photo Tours, Inc., its employees, agents and associates harmless from any liability for my actions while on the trip or tour.

If M&M Photo Tours, Inc. or anyone acting on its behalf is required to incur attorney's fees and costs to enforce this agreement or to defend against claims arising out of my actions while on the trip or tour, I agree to indemnify M&M Photo Tours, Inc. and hold it harmless for all such fees and costs. In the event a lawsuit is filed, I agree that the sole remedy that I may seek is limited to reimbursement of the trip or tour fee and that in no event may a claim for incidental, consequential or punitive damages be brought with regard to this agreement or the performance of this agreement. Any lawsuit arising out of this agreement or the performance of this agreement must be brought in the County of Salt Lake in the State of Utah. I agree that the substantive law of the state of Utah shall apply in any action without regard to the conflict-of-law rules of that state.



Certain M&M vendors require the use of pre-printed tickets which limit the vendor and its owner's and operator's liability. When such tickets are used, I am bound by the terms of these tickets with respect to my legal relationship to the owners and operators, their agents and vendor's employees, subcontractors, and others they may use to operate.

Due to the physical requirements and possible fatigue related to photo tours M&M reserves the right to require individuals with current or past serious medical conditions to provide a medical clearance form from their primary care physician. Furthermore, we reserve the right to deny services to persons who may pose a risk to themselves, others on the trip, or because of their condition(s) may require special assistance/attention which would alter the basic nature of the trip for all guests. Additionally, if any person/client/guest causes disturbance, annoyance, or continued inconvenience to the trip or other persons/client/guests, M&M may send the offending person home with no refund – prorated or otherwise. Govern yourself accordingly.

I have read and agree to the terms and provisions of the Booking Information, as stated in the MM Photo Tour, Inc., website pertaining to my tour, especially noting the policy on cancellations, refunds, and limitations & indemnification on responsibility herein and on the M&M web site.

If any part, article, paragraph, sentence or clause of this Agreement is not enforceable, the affected provision shall be curtailed and limited only to the extent necessary to bring it within the requirements of the law, and the remainder of the Agreement shall continue in full force and effect.

By signing this document, I acknowledge that I agree to all terms herein and if anyone is hurt or property is damaged during my participation in this activity, I have knowingly waived my right to maintain a lawsuit against M&M Photo Tours, Inc. its employees, shareholders, agents and associates, on the basis of any and all claims from which I have agreed to hold them harmless.
